



Trustees Annual Report 2018-2019 – to year ending 5th April 2019

Raising the status of families after homicide and bringing the victim's voice into domestic homicide inquiries to build safer societies.

AAFDA is a centre of excellence for reviews into domestic homicides and for specialist peer support. Working across England and Wales as a national charity, we provide emotional, practical and expert specialist advocacy and help for families after homicide, particularly domestic homicide. We also help agencies to improve their services for victims and to review homicides more effectively.

AAFDA was formed in April 2008 in memory of Julia and Will Pemberton, whose murders in 2003 prompted a huge inquiry exposing the difficulties families face in these circumstances. AAFDA's work raises the status of families after homicide, helping them to cope and to be able to contribute and influence statutory reviews and inquiries.

ACHIEVEMENTS 18/19

WORK WITH FAMILIES

Our core work with families is providing them with expert and specialist advocacy and help after domestic homicide. In the year, 196 families were directly helped, benefiting at least 438 individuals. Our website is also a valuable resource, offering guidance to families and professionals.

In 2018/19, AAFDA extended its work, offering specialist and expert advocacy and peer support to families whose loved ones took their own lives or died in unexplained circumstances and where there is a history of domestic abuse. This is a growing cohort of families that are navigating statutory reviews including the Domestic Homicide Review and Inquest processes without any statutory funded support. AAFDA is ensuring that these families are offered the same level of support as they would be, had their loved ones been the victims of murder or manslaughter following domestic abuse.

AAFDA provided information, peer support, guidance, advice (including access to some free legal advice) and specialist and expert advocacy around Domestic Homicide Reviews (DHR), Serious Case Reviews (now Child Practice Reviews), Inquests, Mental Health Reviews, Independent Office of Police Conduct Investigations and in meetings with agencies such as Health, Police and Local Authorities.

Example **outcomes**:

- After lengthy and difficult negotiations with one Community Safety Partnership (CSP) following a domestic abuse related death, AAFDA persuaded the local area to upgrade the planned narrow local review to be a fully-fledged DHR providing more scope, depth and family involvement. This ensures the review will come under the scrutiny of the Home Office Quality Assurance Panel; this would not have been this case with the review initially proposed by the CSP.
- The best friend of the perpetrator and victim gave a completely different narrative of the nature and mental health difficulties of the perpetrator compared with the narrative of agencies. AAFDA suggested to the best friend he did a pen portrait of the offender and victim in order to redress the balance and then successfully advocated to overcome resistance to have this included in the review. This has changed the whole outlook of the report and highlighted the shortcomings of Social Services, enabling more learning.
- After working with an AAFDA advocate for a number of years through a very difficult and protracted review, one family said "we don't think we would have made it without our advocate".

WORK WITH PROFESSIONALS

AAFDA has offered information, advice and guidance to a range of professionals over the course of the reporting year. This has included providing assistance via our comprehensive on-line resourcing medium and directly.

Example **outcomes**:

- With the help of AAFDA families, South Gloucestershire Community Safety Partnership has co-created a DHR Guide for Families bereaved by domestic homicide. AAFDA facilitated a workshop with 7 families in order that they could review and provide input to the draft guide. This will ensure that South Gloucestershire are providing resources to families that truly meet their needs following domestic homicide.
- As a result of a Serious Case Review and Mental Health Review, the family and AAFDA advocate held meetings with the Mental Health Trust and as a result the Trust now has a policy that addresses the needs of those clients who have learning difficulties and to recognise the individuals who know the client the most and to update and involve them in decision making.

NATIONAL AND INTERNATIONAL INFLUENCE ON POLICY AND PRACTICE

INTERNATIONAL INFLUENCE

AAFDA's CEO, Frank Mullane, was confirmed as a key note speaker at the European Conference on Domestic Violence in Oslo in September 2019. AAFDA's Operations Manager, Sarah Dangar, also had an abstract accepted to present, at the same conference, a workshop on Domestic Homicide Reviews following domestic abuse related suicides and unexplained deaths.

CEO Frank Mullane was invited to speak in Portugal and Ireland later in 2019 to lend his expertise to countries whose development of domestic abuse related deaths is in a nascent stage.

TRAINING, WORKSHOPS, PRESENTATIONS

Delivered three two-day courses training professionals to Chair Domestic Homicide Reviews:

Feedback from a delegate following Domestic Homicide Review (DHR) Chair training:

"What brilliant training! Thanks so much for a very thought-provoking couple of days. I particularly liked how family focused it was and has made me re-think families in all my work, not just SCRs [Serious Case Reviews]. On reflection I am wondering about practitioner involvement and as a Chair how to make sure their voice is heard and not filtered by the organisation."

Designed and delivered a number of bespoke workshops, events and presentations to local areas to improve their statutory review practice. Examples include:

- Bradford Regional Learning Event: The first regional event that AAFDA has hosted in the North of England with the aim of sharing best practice in Domestic Homicide Reviews. It was well attended with 48 delegates. Feedback from the event was overwhelmingly positive with 83% rating the event as 'Excellent' and the remaining 17% rating the event as 'Good'.
- Training to NHS practitioners on recognising domestic abuse.
- 16 days of action conferences – CEO gave key note addresses in Hertfordshire, Thames Valley, Kent and Buckinghamshire.

- Presented and delivered training to several audiences of public protection officials around the country including in the Thames Valley, Worcester, London and the South West.

Feedback from Bradford event –

I have regained my focus on the reason why I carry out these reports – The person and the family and to learn. Other feedback on AAFDA training events:

The attendance of victims’ families at training events reminds attendees of the impact of death resulting from domestic abuse. It is a poignant reminder that reviews have a responsibility and duty to victims via their families.”

Additionally, AAFDA collaborated with other individuals and charities to deliver several ‘Making Families Count’ workshops to a number of NHS Trusts.

PEER SUPPORT

'HEAR OUR VOICE' pilot

We facilitated three peer support events, two residential events in Devon and one peer support dinner on the eve of our annual conference.

16 families (33 family members) attended the residential events. These families had never had the opportunity to share their stories with other similarly bereaved families.



The third event, a dinner, enabled 44 families (73 family members), 10 AAFDA staff and some friends of AAFDA to come together. This was held the night before our annual conference in Swindon (March 2019). This was thought to be the largest gathering ever of families bereaved by domestic homicide.



Feedback from the residential events:

- 100% of survey respondents rated the event 'Excellent' or 'Very Good'
- When asked 'What did you like about the event?' families responded:
 - "Being able to connect with such wonderful families who I was able to talk to and know we have a connection and understanding of each other sadness"
 - "A chance to meet people who simply 'get it'. The event helped us to realise we are not on our own"
 - "Meeting with other people that understand the situation and how to make it possible for us to be able to talk about it"
 - "meeting other people who knew exactly where we've been emotionally it's an elite club no one wants to join"



- When asked if there was anything else, they wanted to share about the event, families said:
 - "This was a great opportunity to meet other families in the same position as ourselves and to be able to talk freely and openly this helped us and I am sure helped the other families this was a great idea and if done again will help more families on the path to try and get back to a normal life"
 - "Best therapy for grieving families"
 - "It was so good - the people the food the venue so nice to be away from the everyday worries that we all live with it was the fun of it we really relaxed over the weekend more please"
 - "just the medicine I needed"

STAFF AND VOLUNTEERS

Demand for AAFDA's services continues to grow as does its reach.

We recruited one additional advocate (bringing the total to 7). This new advocate is an expert in children and adolescents and will be working in part on a new project that AAFDA is piloting in partnership with AVA (Against Violence and Abuse) in the financial year 2019/20. This work is specifically focussed on giving children, bereaved by fatal domestic abuse, a voice in Domestic Homicide Reviews. Whilst the Home Office statutory guidance calls for this, children are often left out of the process despite having vital information to offer that can help to transform the future response to all victims of Domestic Abuse.

This project involves focus groups with professionals working on reviews after fatal domestic abuse and direct work with families and children. The outputs of this project will include toolkits that will support professionals to give children voices in future reviews as well as training for Domestic Homicide Review Chairs.

We also recruited a Finance and Admin Officer to support the team and a Development Manager funded by a Home Office grant to embed advocacy in DHRs, a one-year project starting 6 April 2019.

Nine volunteers helped AAFDA in the year, including by directly helping families, providing legal advice, criminology expertise, research findings, help with the conference and administrative assistance.

AAFDA is delighted that CEO Frank Mullane was awarded an MBE in the New Year's Honours list 2018 for his services to families bereaved by domestic homicide. Additionally, Frank was invited to sit on the recruitment panel for the first Domestic Abuse Commissioner for England and Wales and also sits on the National Victims' Panel chaired by the Justice Minister.

FINANCE

Income for 2018-19 was £367K and costs were £354K. AAFDA's primary funders were: The Home Office (£100K), the Ministry of Justice (£34K), Esmée Fairbairn (£47K), Victim Support (£40.5K, some income deferred into following year) and Henry Smith (£45K). A further £48K was generated through consultancy work, allowing AAFDA to create unrestricted reserves to strengthen the financial position. AAFDA undertakes regular strategic review to inform our fundraising strategy.

Reserves Policy

AAFDA grew significantly amidst a very uncertain funding environment. Therefore, the Trustees considered future income and expenditure and the risks facing AAFDA and aimed for reserves to be between three and six months of the following year's forecast expenditure after designated funds. We are on target to sustain reserves in this range which ensures financial resilience and complies with the Charity Commission's guidance.

Public Benefit Statement

The trustees have complied with their duty to have due regards to the guidance on public benefit published by the Charity Commission in exercising their powers or duties. This includes, for example, being clear that the activities AAFDA undertakes are for the public benefit.

Financial Review

AAFDA has prepared accounts on the accruals basis. They show a true and fair view.

CONSTITUTION AND ORGANISATIONAL STRUCTURE

AAFDA is an unincorporated association formed on 1 April 2008 (will become incorporated in 2020). It adopted an amended constitution on 23 July 2008 and became a registered charity on 19 September 2008.

Governance and how AAFDA makes decisions

Our Board comprised of four trustees and includes a local authority strategic Violence Against Women and Girls lead and expert in the Criminal Justice Sector, a Safeguarding lead for a Clinical Commissioning Group, a Senior Health Advisor, and a specialist charity Lawyer.

The AAFDA Board met at least on a quarterly basis when the CEO and Operations Manager reported on the main aspects of the charity (work with beneficiaries, impact on victims, emerging issues, finance, strategic plan and operational performance and risk). The Board is aware of its responsibilities to identify and manage risk.



The Board complied with statutory obligations to submit Full Year Accounts, a Trustees' Annual Report and an Annual Return to the Charity Commission.


Trustee Induction and Training
